Terms & Conditions



Terms:

- Product quoted is subject to availability. Should any product not be available at the time of your event they will be replaced with a product of equal value and quality. Content may vary depending on site conditions on the day of the display to ensure compliance with state regulations and safety management procedures.

Safety and public issues

- Skylighter Fireworks will determine where it is safe for the public to view the fireworks display.
- Skylighter Fireworks will provide safety tape and bunting to secure the firing site. Crowd control, security and any safety fencing for the fireworks display (before, during and after) is the responsibility of the client.
- It is the responsibility of the client to provide adequate protection for all the Skylighter Fireworks equipment, so as to prevent unauthorised interference or removal from the time that Skylighter Fireworks arrives at and departs from the venue.
- Permission to use the land for the fireworks display site must be obtained by the event organiser at least 14 days prior to the fireworks display. Skylighter Fireworks will assist the event organiser where possible.
- It is the responsibility of the event organiser to advise the surrounding neighbours of the firing time, date and place at least 3 days prior to the event, for an additional fee of \$150 Skylighter Fireworks can arrange this.
- Any product and/or display malfunctions or client dissatisfaction of any products and/or service must be reported on the night or within 24 hours to the Display Manager or Head Office.

Insurance

- Skylighter Fireworks Pty Ltd carry \$20M Public and Product Liability Insurance. Requests for nominated insurance indemnification must be made a minimum of 7 days prior to the display.

Cancellations

- Skylighter Fireworks have the right to cancel a fireworks display prior to or during the performance due to public invasion of security and safety distances, product malfunctions and unsafe weather conditions without incurring any penalties in payment from the client. Skylighter Fireworks will only refund the cost of products not used in the event that are deemed safe for re-use.
- If the client wishes to cancel the fireworks display, 4 weeks notice is required. Notice must be in writing.
- If the client cancels the fireworks display within 4 weeks of the display a cancellation fee will be charged. The cancellation fee will include all costs incurred for the fireworks display prior to the cancellation, these costs may include administration services, manufacturing, packing, labour, hardware and transport. The maximum fee will not be more than 50% of the contracted price.
- Booking fees are non refundable if a fireworks display is cancelled within 7 days of the proposed fireworks display
- In the event of a total fire ban and permission for the fireworks display has not been granted by the local fire authority, a cancellation fee will be charged to the client.
- If the fireworks display cannot proceed due to unsafe weather conditions both parties can agree to cancel, postpone or delay the fireworks display. Cancellation fees apply. Additional labour charges will be incurred if the display operators have departed the Skylighter Fireworks warehouse and are en route to the fireworks display site.
- If any services are subcontracted out by Skylighter Fireworks to provide the agreed fireworks display and the fireworks display is cancelled the client must pay all costs for these services in full within 7 days of cancellation (ie barge hire, security services, etc).

Payment Terms

- A 20% deposit on booking is required, with the balance due on/before the night (either by cheque or proof of direct deposit) unless other arrangements have been made with Head Office.
- Payment must be made in full on or before the day of the fireworks display unless otherwise agreed.
